There were 19 clubs that have submitted rosters. In some cases, clubs had to submit 2019 roster information due to not being able to meet. The Pennsylvania Guppy Club did not submit a roster or respond when contacted.

There were no inquiries about forming a new IFGA club.

Because most people can easily get information about joining the IFGA through the website, I received no inquiries about becoming individual IFGA members. When there are inquiries, the IFGA president is usually contacted.

As a reminder, our constitution requires that club rosters include the name, address, phone number, & email address of members. Some clubs still have names of members without additional information. Unless the address and contact information are included with the club roster, these club members cannot be counted towards the five-core member or three IFGA dues paying member requirement.

Judging Board Report – Jim Alderson

Judging Board Report

Due to the pandemic, all requirements to maintain your judging status have been suspended. The only requirement that remains in effect is that you must remain an IFGA member to maintain your judging status. If shows go on as scheduled next year, remember that the HB White class has been added to the required classes for an IFGA show. HB Whites entered in the HB Pastel class will be disqualified. If an entry in the HB pastels class has some degree of a secondary pastel color, it will remain in the HB pastel class. The judging Board's goal is to make this transition with a minimal number of disqualifications. Conversely, If A HB White fish has in its caudal fin a secondary pastel, color it will be disqualified. The Judging Board may address these standards after we have had a year of showing these fish with the new class in effect. It is difficult to change a class that has been in effect for over 50 years without some adjustment on the part of exhibitors, but the Judging Board will work to the change as smoothly as possible. As the judging Board Chairperson, I am going through my records to try and get the current email address of all the judges on one list so that the Board may communicate with the Judges directly. Many of the email addresses I have on record are not active. If you are a judging board member, please send your current email address to guppychampion@aol.com. Depending upon the trajectory of the pandemic and the execution of the show season, there may be other judging related virtual educational events planned by the Board to keep the Judges up-to-date and engaged. There are some judging topics in which the Board has expressed a need for further clarification and education of the judges. These include HB White, HB Pastel. HB body-color, body-color in general and how these points are allocated, and the minimum requirements for the snakeskin, gold, and bronze classes. Let's hope for a full show season next year.

Awards Report-Greg Billings

The 2020 IFGA Point Show season is historical. For the first time that I know of, multiple shows were cancelled due to concerns outside the control of the IFGA or the hosting clubs. The Covid 19 pandemic is also a concern for the up-coming 2021point season. We can't compare total season entries as I have in the past because of the 2020 season's single show but we can compare each season's annual. Unfortunately, the 2020 IFGA points show season started with an annual with only 534 entries. In the last four years entries to the annual show entries have dropped from 706 entries in 2016 to 534 entries in October 2019 (706→680→573→534). As we all know there was no annual in October 2020, but let's all work towards an increase in entries during the next show season and especially at the October 2021 annual. The annual is the one place we all have to meet the largest number of IFGA members in one place.

Please remember that at the last annual, the judging board explained their logical decision to promote the provisional "Half Black White" class to official IFGA class status while the provisional "All Color Wide" class was not. With the cancellation of all the rest of the 2020 shows we never had a chance to see growth in the entry participation of this new formal class but with this extra time to breed, let's hope the Half Black White class sees a dramatic increase in entries. Knowing that your HB Whites will be "Disqualified" (DQ) in the HB Pastel class, why not work on a true separate strain.

While the "All Color Wide" is not an official IFGA class, any hosting club can offer a class such as "Roundtail", "Any Other Shape" or whatever has interest in your club. Should your club elect to do so, please let Roy or me know well ahead of your show so we can alter the registration software to tally your unique club sponsored class. Note however, that the hosting club is responsible for that class' plaques; it should be mentioned in your show posting; and points will be tallied for your show but not included in the IFGA's point totals.

The points of all the season's entries are now being tabulated by myself AND Roy O'Doherty. Join me in thanking Roy for volunteering to ensure the validity of all the posted data of the 2019 and 2020 show seasons and to learn the duties of the Awards Committee Chair. Roy has worked hard to understand the scripting code that guides the intricate excel software to tabulate all the rankings.

As you must know by now, the single 2020 show (October 2019 Annual) will be combined with the future shows of the 2021 show season to form a 2020-2021 show season. Roy and I will be working on the code or a strategy to combine the two years of shows into one tally.
